1. **Contact** the administrator of your account for a change-of-beneficiary form or download a form from your provider's website.
2. **Decide** what percentage of the account you wish to give to Atlanta Humane, and name Atlanta Humane, along with the stated percentage, on the form.
3. **Sign** and return the form to your plan administrator, insurance company, or bank.
4. **Tell** Atlanta Humane about your gift! We want to thank you and include you in our Legacy Circle events.
